**RELEASE OF LIABILITY**

do hereby release, discharge, defend and agree to hold harmless Green Valley Country Club (GVCC), its officers, directors, members, employees, agents and each of them (hereafter "releasees") from any and all liability, claims, damage, or demands for personal injury, sickness or death, as well as property damages and expenses, of any nature whatsoever which may be incurred by the undersigned and/or the child participant that occur while participating in GVCC's swimming pool activities, programs, transportation to and/or from swim team practices and swim team meets.

**Furthermore**, the undersigned (including participants named above) hereby assume all risk of personal injury, sickness, death, damage and expense as a result of participation in recreation and work activities involved in such activities, programs and transportation.

**The undersigned further hereby agrees** to hold harmless and indemnify releasees for any and all liability sustained by releasees as the result, of negligent, willful acts of the undersigned (including without limitation above named participants) including expenses incurred related thereto, regardless of the active or passive negligence, or willful misconducts of releasees, to the extent allowed by law.

I further understand that it is possible for serious injuries to occur during participation in or related to the GVCC swimming activities, programs and/or transportation that a participant may be injured by others as a consequence thereof. Knowing the risks of such participation, nevertheless, I hereby agree to assume those risks and to release, discharge, defend and hold harmless all releasees.

**I (we) are the parent(s) or legal guardians(s) of this participant**, and hereby grant our (my) permission for him/her to participate fully in said activities, programs and transportation and hereby give our permission to take said participant(s) to a doctor or hospital and hereby authorize medical treatment, including but not limited to emergency surgery or medical treatment, and assume the responsibility for payment of all medical bills, if any, even though liability, damage or claim may arise out of or connected to passive or active negligence or willful misconduct of releasees.

It is further understood and agreed that this waiver, release, and assumption of risk is to be binding on my heirs, personal representations and assigns. I/we also understand that if I/we violate any of the swimming rules as established by releasees I can be penalized or disqualified and/or prohibited from participating in any further GVCC swimming program and activities.
